It is understood that Boatworks of Buffalo has exclusive sale right for the above named vessel. In the event that the vessel is sold or otherwise disposed of by donation, trade, etc. during the term of the agreement, the Owner, agrees to pay BoatWorks of Buffalo a commission of ten percent (10%) of the gross sale price of the vessel or a minimum \$1200.00 commission/brokerage fee. In case of sale or exchange is made within one year after the termination of the agreement to parties who were initially contracted and informed of the availability of the vessel at any time during the term of the agreement, the aforesaid commission shall be due upon such transaction.

In the event of non-payment by the owner of the commission due herein, owner shall be liable for reasonable attorney's fees and all costs associated in the collection of said commission.
